<u>Treasurer Report</u>: We have approximately \$16,000 in cash and approximately \$2,000 in loss through 2014. There is \$23.00 in professional fees. The motion to approve the treasure report was made by Judy and seconded by Larry. Motion was carried and approved by all board members present.

The Treasurer position uses QuickBooks. The monthly hours of use for this position is minimal except for large events such as the Lighthouse Charities Regatta and the beginning of the year for membership renewal.
